PROSPECT/DONOR MEETING CONVERSATION GUIDE

INTRODUCTION | SET CLEAR PARAMETERS FOR THE MEETING:

- Thanks for meeting with me/us.
- As you know, we want to update you on our effort to increase student scholarships and how your increased support can make an impact on our law school and its students.
- We know your time is valuable and we want to be sure you leave today's meeting with a better understanding of the impact that scholarship support has, how your past support has directly made a difference and how increased support of our efforts can allow us to serve more students and strengthen our law school.

RAPPORT | GET CONTROL OF THE MEETING FROM THE OUTSET

- Thanks for taking time to meet with me to discuss USD School of Law. You've been a generous supporter of our efforts and we truly appreciate the impact you make through your philanthropy.
- As you know, I wanted to discuss what our law school is doing to continue providing a world-class education for our students and how we can involve you in our efforts, but before we get to that, I wanted to ask you a few questions about your experience as a student and alumnus of our law school.

CONTROLLING TANGENTS | DONOR IS PONTIFICATING ON POLITICS, SPORTS, ETC...

- I could talk to you about the poor state of the basketball program all day, but I know we have limited time today and I want to be sure we have time to discuss our Center on Intellectual Property Law & Markets.
- As you know they have an upcoming symposium on copyright infringement. Have you had a chance to see the program?

IDENTIFYING WHEN TO ASK

- Have you identified giving priorities?
- Have you effectively outlined a case for support related to those giving priorities?
- Are you a philanthropic priority for the donor?
- Do you know that the time/project are right for the donor?
- Is the ask part of a larger strategy?



THE ART OF MAKING THE ASK

- Guide the conversation to build to YES
- Track their positive responses (from this and past conversations) and utilize in transitioning from your case to the ask

CLOSING SAMPLE QUESTIONS

- Are you in a position to decide at this time?
- Would you like to bring your spouse/partner to see the program?
- What further information do you need?
- Can I introduce you to the chief "x" involved?
- Would you like to think about the opportunities for having your name on x?

An admired and respected teacher and scholar, Professor Maudsley served at USD School of Law until his death in 1981.

USD School of Law International Programs

USD School of Law offers legal education opportunities in Europe, Asia and Latin America. Fully integrated with the law school's regular international and comparative law course offerings, USD's four law summer study abroad programs and eight semester abroad programs provide a strong curricular focus.

USD's summer study abroad programs are open to USD law students and students enrolled in ABA accredited and foreign law schools. They provide intensive training in international, comparative and foreign law, while introducing American students to the legal institutions of another country. At the same time, students from Commonwealth and civil law traditions experience American legal viewpoints and problem-solving methods. Programs bring together students and expert faculty for a rich experience of academic and cultural interchange.

Summary of Your Support
