Discussions around when to notify parents, what information must be shared versus should be shared, and how FERPA intersects with parent notification will be discussed.

#### Weighing Disciplinary Action and Discrimination Laws

Another role that Deans of Student have to exercise is serving as the campus adjudicator for high-level cases and/or serve as the designated sanction officer once a student conduct case determined a finding of responsibility for a policy violation. Sometimes these disciplinary decisions become more complicated when the accused student or student found responsible for violating campus policy also has documented information on file regarding their mental health concerns. A review of discrimination laws, in this context, is a critical topic of discussion for Deans of Students to analyze when weighing disciplinary action for a student who also happens to have a reported mental health concern.

#### Parent Notification and Discrimination Laws Tabletop Exercise

Ms. Wolf is immediate Past President of the National Behavioral Intervention Team Association (NaBITA), a membership association serving more than 1,500 professionals in schools, colleges, and workplaces whose role is to support individuals in need of mental health intervention and to minimize the potential for school and workplace violence. She is also a frequently invited speaker and consultant to healthcare and mental health organizations, as well as institutions of higher education, specifically university counseling centers and administrators, and professional associations throughout the country regarding mental health law issues and many of the above-mentioned topics. She has been selected to the New York Super Lawyers list since 2013.

Ms. Wolf holds a J.D. from Hofstra University School of Law, an M.S. in Health Services Administration from the Harvard School of Public Health and an M.B.A. in Management from the Hofstra University School of Business. She is admitted to practice in New York State and Federal Courts as well as the U.S. Supreme Court. In addition, Ms. Wolf is an adjunct professor at Maurice A. Deane School of Law at Hofstra University, teaching "Law and Psychiatry." Prior to practicing law, Ms. Wolf was a hospital administrator and Director of Hospital Risk Management.

In her current role, she is providing divisional leadership as NIU is undertaking an organizational restructuring of the Division of Student Affairs as well as establishing the institution's first Dean of Students Office.

Dr. Wesener Michael's academic credentials include: Doctorate of Education in Educational Leadership and Policy Studies from Indiana University, Masters of Science in College Student Personnel from Western Illinois University and Bachelor of Arts from the University of Wisconsin – Stevens Point.
