It is critical for every institution to fully understand the differences between a criminal and civil rights investigation before investigators can be properly trained. We will thoroughly outline the differences between civil rights and criminal investigations, potential "investigative" issues, important considerations (e.g., policy driven, bias and stereotype, credibility, etc.), policy analysis, and standard of proof to help you develop a framework for your investigative practices.

Planning/Pre-Investigation/Strategizing the Investigation

Investigations must be thoroughly planned before they can be conducted properly. We will provide an overview of the planning process, including:

- How to identify the potential type(s) of sexual misconduct
- Organizing information on the named witnesses, their roles, and the order of questioning
- Designing a plan to interview witnesses

- Evaluating writing for personal bias
- · Identifying policies relevant to facts
