UW transformed a 1970s library lacking modern infrastructure into a one-stop, state-of-the-art facility, featuring high tech active learning classrooms, co-located research and writing services, and strategic design that fosters formal and informal learning. The impact from this project has catalyzed new service-delivery models shared with the academic library community nationwide. You will also have the chance to participate in a panel discussion with the key decision-makers and stakeholders behind the design and implementation of these efforts.

Niraj Chaudhary

Director of Technology and Digital Initiatives for University Libraries, University of the Pacific

In his current role, Niraj Chaudhary is leading the technology planning and budget development for a comprehensive facility renovation of the Stockton campus library. Previously, he served as Head of Information and Educational Technology Services for Auraria Library, which serves University of Colorado Denver, Metropolitan State University of Denver, and Community College of Denver. At Auraria Library, he provided technology vision and led many successful technology implementations, including the Discovery Wall during its comprehensive facility renovation from 2008 to 2016.

John Danneker

Director / Learning Services, University of Washington Libraries

John Danneker is the Director of Learning Services at the University of Washington Libraries in Seattle, a sixty-person department which includes all Libraries' staff housed in Odegaard Undergraduate Library. He joined the UW in 2014 after a decade-plus of work in academic libraries in Washington DC.

John leads Learning Services in advancing the UW Libraries Mission & Vision through the lens of teaching, learning, and engagement, and provides leadership and strategic thinking in these areas within the UW Libraries in support of the UW community. The four-unit department supports the whole student by deepening learning related to inquiry and the critical use of information, while acknowledging that important learning occurs both inside and outside of the formal classroom setting.

Professionally, John is particularly interested in how we translate the concept of learning environments into both our personnel and physical structures, and how we grow limited capacities in a sustainable way to embrace strategically-chosen projects. John believes a building can be one enabler of change, and feels that good academic libraries instill a sense of belonging for users while offering access to resources, spaces, programming, and staffing. He regularly writes about and presents on the importance of collaborations and partnerships in academic libraries, in addition to his active participation in national libraries organizations.

Kristin Kelsey

Architecture and Design Lead, HermanMiller; Adjunct Professor, University of Oregon, Portland

Kristin Kelsey is the Architecture and Design Lead for the northwest region. Kristin has over eight years of experience working in both the architecture and interior architecture fields. She holds dual Master's in Architecture and Interior Architecture from the University of Oregon. Kristin approaches building programming and design from perspective of identifying programmatic opportunities to create considered and complete solutions.

Kristin spent the last five years as part of the design staff and an Interior Architecture leader at the Miller Hull Partnership. She worked primarily on tenant improvements, commercial and higher education projects. Kristin was an interior architecture leader at The Miller Hull Partnership. She highlighted chemicals that are present in finishes and building materials and helped remove them, finding alternatives for all future Miller Hull projects. She completed Miller Hull's Seattle studio renovation, which became Petal Certified in April 2017.

Kristin is currently an adjunct professor at the University of Oregon in Portland teaching in architecture and interior architecture.

Jill McKinstry

Librarian Emeritus, University of Washington (UW)

Jill McKinstry is Librarian Emeritus of the University of Washington (UW) and former director of the Odegaard Undergraduate Library and special assistant to the dean of University Libraries for undergraduate education and programs at the University of Washington. Jill is a graduate of the University of Washington Information School and a librarian at the UW for almost 30 years. In 2013, Odegaard Library underwent a much-needed renovation on the 42-year-old building, adding 6,000 additional square feet of useable space on the first floor, new study spaces, skylight, and state of the art active learning classrooms. The renovation received several awards: 2013 AIA Seattle Honor Awards | Honor Award; 2014 AIA National Institute for Interior Architecture Honor Awards | Honor Award; SCUP (Society of College and University P) Design Excellence Award Excellence in Architecture (Category: Building Additions or Adaptive Reuse) | Honor Award; and ALA IIDA (American Library Association & International Interior Designers Association); Library Interior Design Awards (Category: Academic Libraries / Over 30,000sq ft) | Honorable Mention.

Kristin Meyer

User Experience Librarian, Grand Valley State University

In her current role, Kristin focuses on understanding and improving the student experience of the Mary Idema Pew Library Learning and Information Commons. This state-of-the-art facility opened in 2013 and has been described as a model of twenty-first century learning. Kristin has conducted post-occupancy assessment and ongoing user research designed to improve user experience within the space and, by extension, the academic experience of students. As a Certified Customer Experience Professional (CCXP) and with over sixteen years of library experience, Kristin has a unique view on how spaces can support learning and community.

Lee Van Orsdel

Previous Dean of Libraries, Grand Valley State University

Lee has 45 years of leadership experience in academic libraries in Alabama, Kentucky, and Michigan, including reorganization, staff development, leadership, program innovation, and library design. Recently retired, Van Orsdel was dean of university libraries at Grand Valley State University from 2005 to 2016. Under her leadership, GVSU libraries won the 2012 ACRL Excellence in Academic Libraries Award for universities and the 2014 State Librarian's Excellence Award. Van Orsdel supplied the vision for Grand Valley's new main library, which was designed by Stantec Architecture. The \$65 million LEED Platinum project opened in June 2013 and has since welcomed almost four million visitors. A multi-faceted post-occupancy study by Steelcase Corporation confirmed that the vision was fully realized. In September, the library was named a New Landmark Library by Library Journal.

Mary M. Somerville

University Librarian, University Libraries at University of the Pacific

Dr. Mary M. Somerville brings years of fundraising and library renovation experience from two major campus projects including her current position as University Librarian since 2016 for University Libraries at University of the Pacific—one university with campuses in San Francisco, Sacramento, and Stockton, California. There she is currently advancing a comprehensive library facility renovation, her second. From 2008 - 2015, she was furthering fundraising and vision-setting for design and construction of the Auraria Library, a shared facility academic library serving University of Colorado Denver, Metropolitan State University of Denver, and Community College of Denver.
